## Thuringowa Bird Club Inc – 2010 Bird Sale -SALE CONDITIONS

1. Birds offered for sale are **restricted** to the following Schedules of NCR 2006: Exempt Schedule, Controlled Schedule, Recreational Schedule, Commercial Schedule (Native birds) and Domestic Schedule (non-native birds).
2. Strictly no Hybrids, Poultry, Domestic Pigeons. Show (Fancy) Pigeons excepted.
3. The vendor of native birds is to provide a Mov Advice, if applicable, to the Stewards, on arrival. TBC Inc will provide vendor with sufficient Mov Advice for buyers. Sellers are responsible for raising Mov Ad for buyers as required. Return of un-sold birds to vendor requires a Mov Advice from TBC Inc. There is no charge for return Mov Advice.
4. **On arrival, the vendor of native birds is to present their appropriate licence (if required), to the Stewards.**
5. Sales Tables will only be allotted on receipt of payment in full and receipt of Registration Form.
6. Late registration is at the discretion of the Stewards and may be refused if there is insufficient display space. A late registration Fee of \$10:00 may apply.
7. Vendor entry for benching from 7AM on the 16<sup>Th</sup> May 2010. All birds/product are to be benched NLT 8:30 AM.
8. Vendors are only permitted to have **ONE** assistant during the benching period. No others will be permitted entry. Vendor entry is at no charge. **Vendor assistants will be charged an entry fee of \$2:00. No exceptions.**
9. **The sale of birds outside of the registered sales venue is in breach of NCR 2006 and is therefore strictly prohibited.**
10. All vendors are to be aware and conversant with the regulations governing the sale of native birds. Vendors are to advise buyers of their responsibilities accordingly. 11. ***All sale cages/boxes are to comply with the standards as listed below:***
  - a. ***Cages/boxes are to have the three sides, top and bottom, made of a solid material. The front is to be of suitably sized wire. Alternately, a full mess/barred cage that has the sides, back, top and bottom enclosed with a suitable material eg: MDF sheet, may be accepted at the discretion of the Stewards. Any queries please call Jim vR.***
  - b. ***All cages/boxes are to contain/have suitable feed and water, sufficient for the duration of the sale.***
  - c. ***Overcrowding of birds in cage/boxes is not permitted. Steward's discretion is final. Recommend no more than four birds per cage/box (finches excepted).***
12. The Stewards reserve the right to reject entry or display for sale, any bird considered to be in poor health or condition, or, displayed in any cage/box not considered suitable for sale.
13. Doors open to the Public at 9:00AM and sales cease at 12:00PM. All birds/products cleared from venue NLT 2:00PM.
14. Suitable escape proof exchange cages will be provided at the venue. Vendors are to use this facility for the safe transfer of birds. Any escapees are to be immediately notified to the Stewards.
15. Vendors are strongly encouraged to issue a receipt or MTR (as applicable) for the sale of any bird (s). This is particularly important for birds on the Exempt and Domestic Schedule.
16. Vendors are also encouraged to ensure that buyers, particularly “first timers”, are advised either verbally or by a written hand-out, on general requirements for the care of the bird (s) purchased.
17. Birds that require a Mov Advice may only be removed from the venue, on presentation to the Stewards, of the appropriate Mov Advice.
18. Thuringowa Bird Club Inc accepts no responsibility in any matter relating to loss or injury of any bird or product, or as to the condition of any bird or product sold.
19. Vendors are required to keep the Sales area tidy and ensure any rubbish etc is placed in the bins provided, prior to exiting the venue.
20. The Stewards reserve the right to interpret the above Sale Conditions at their discretion. In any dispute, the Stewards decision will be final and binding.
