Site Allocation cost \$25:00 (equiv. 1 table) with **all Vendors & assistants** being **MEMBERS** of an Affiliated Bird Club that has Public Liability Insurance with the Canary and Cage Bird Federation of Australia Inc. ie. TBC Inc.

Vendors are required to book & pay for the total number of Site Allocations they require.

Display boxes may only be *STACKED (on top of each other)* two boxes high.

Vendor entry for benching from 06:00AM on the 18th May 2025. See also Sale Conditions #4. All birds/product are to be benched **NO** later than 8:30AM.

Doors open to the Public at 09:00AM and sales cease at 12:00noon.

There is NO 'Viewing Time' nor are Buyers/Public to be in the Venue prior to 9.00AM Public Door Opening.

All birds/products to be cleared from venue no later than 2:00PM.

Sellers MUST be identifiable to/by the Public with Name, Phone Number, Business, Address. If, by reasonable request by a Buyer, TBC Inc. may advance information of a Seller to the Buyer.

COVID Restrictions may be 'in place' at the time of Sale.

2025 BIRD SALE CONDITIONS

1. Birds offered for sale are restricted to the Native Animal Schedules 2020 of Exempt Schedule, and WA Licensed Animals and Non-native birds.
 Strictly no **FIRST-CROSS** Australian/QLD Species Hybrids, NO Poultry, NO Domestic Pigeons.
All sale cages/boxes are to comply with the standards as listed below:
 - A. cages/boxes are to have the three sides, top and bottom, made of a solid material. The front is to be of suitably sized wire. **Any queries please call Greg Dadswell. Any birds in a cage/box not meeting these standards will be excluded.**
 - B. cages/boxes are to contain/have suitable feed and water, sufficient for the duration of the sale. Feeders should be at **Perch Height**. Overcrowding of birds in cage/boxes is not permitted. Steward's discretion is final. **Recommended, no more than 2 birds & ONLY Compatible SPECIES per cage/box (finches accepted with Max Numbers still limited).** The Steward reserve the right to reject entry or display for sale, if sighted, any bird considered to be in poor health or condition, or, displayed in any cage/box not considered suitable for sale. This Sale is still Buyer be-ware.
2. **A hand written list** of all birds to be given to Steward before Sale commences
3. Late registration is at the discretion of the Steward and may be refused if there is insufficient display space. A late registration Fee of \$10:00 per Site allocation will apply.
4. **Vendors are only permitted to have ONE Assistant** (as listed on your Registration) during the Benching & Sale period. **No others will be permitted entry. No Exceptions. Due to Public Liability Insurance, PRIOR to SALE, All Vendors and their assistant must be members of the Thuringowa Bird Club Inc. or members of a Club Affiliated with the Canary & Cage Bird Federation of Australia Inc. There will be no exceptions to this rule.**
5. The sale of birds outside of the registered sales venue is in breach of NCR 2006 and is therefore strictly prohibited.
6. All vendors are to be aware and conversant with the regulations governing the sale of native birds. Vendors are to advise buyers of their responsibilities accordingly. Guidelines may be downloaded from <https://www.qld.gov.au/environment/plants-animals/wildlife-permits/permit-types/wildlife-licence/native-animal>
7. Thuringowa Bird Club Inc. accepts **NO** responsibility in any matter relating to Licensing or MA's.
8. Suitable escape proof exchange cages will be provided at the venue. Vendors are to use this facility for the safe transfer of birds. Any escapees are to be immediately notified to the Steward, but remain the responsibility of the **Vendor** to recapture ASAP.
9. Vendors are strongly encouraged to issue a receipt or MTR (as applicable) for the sale of any bird (s). This is particularly important for birds on the Schedule.
10. **Sellers MUST be identifiable to/by the Public with Name-Phone Number-Business-Address. If, by reasonable request from a Buyer, TBC Inc. may advance information of a Seller to the Buyer.**
 Vendors are also encouraged to ensure that buyers, particularly "first timers", are advised either verbally or by a written hand-out, on general requirements for the care of the bird (s) purchased.
11. Thuringowa Bird Club Inc. accepts no responsibility in any matter relating to loss or injury of any bird or product, or as to the condition of any bird or product sold/purchased. Buyer Beware..
 Vendors are required to keep the Sales area tidy and ensure any rubbish etc. is placed in the rubbish bins provided, prior to exiting the venue.
12. The Stewards reserve the right to interpret the above Sale Conditions at their discretion. In any dispute, the Steward's decision will be final and binding.
13. **Insurance:** Bird sellers must be a member of an insured club affiliated with the Canary and Caged Bird Federation of Australia Inc. Trade Seller must have their own business/public liability insurance and must produce a current copy to the club prior to the bird sale. Payment of the current **membership fee** or confirmation of current membership of an insured club affiliated with the CCBFA Inc is required.
14. **PETS** All pets are banned from the Bird Sale. Guide Dogs are exempt with Assistance dogs to be Licensed & accessed.
15. **NO Photograghy of the event is allowed unless previously requested & permitted, in writing.**
